Chairman Pichini moved to go into a brief executive session to discuss a personnel issue.

REMARKS OF THE CHAIR (continued)

Chairman Pichini noted that in addition to the executive session just concluded, the Board also met in executive session on Thursday, July 25, 2013, concerning the chancellor search from 9:03 a.m. to 4:26 p.m. No action was taken during either of the two executive sessions.

Chairman Pichini noted there was one action item on the agenda to consider – the selection of the Pennsylvania State System of Higher Education's (PASSHE) next chancellor.

Chairman Pichini thanked the members of the Chancellor Search Committee for their work throughout this process. Chairman Pichini noted the committee spent numerous hours together over the last several months and was confident everyone would be pleased with the end result.

Chairman Pichini also thanked the constituency groups who assisted the search committee, both in the development of the position profile and in the final interviews.

Chairman Pichini acknowledged Acting Chancellor Dr. Peter Garland for his outstanding leadership over the last several months and indicated that Dr. Garland would be recognized at the next regular Board meeting in October.

BOARD ACTION

CHAIRMAN PICHINI REMARKS REGARDING THE APPOINTMENT OF THE CHANCELLOR

Chairman Pichini noted that over the last six months the Board was engaged in the important process of searching for PASSHE's next chancellor. The search generated tremendous interest, with several hundred individuals from across the United States inquiring about the position. The Chancellor Search Committee reviewed the applications and nominations submitted from individuals of varied backgrounds—traditional and nontraditional—and who were culturally diverse. It was a very strong pool.

Chairman Pichini said the Board interviewed the final three candidates on Thursday, July 25, 2013.

Mr. Henry moved that THE BOARD APPROVE THE APPOINTMENT OF FRANK T. BROGAN EFFECTIVE OCTOBER 1, 2013, AS THE CHANCELLOR OF THE PENNSYLVANIA STATE SYSTEM OF HIGHER EDUCATION AND AUTHORIZE THE CHAIRMAN TO EXECUTE THE NECESSARY DOCUMENTS.

Ms. Conley seconded the motion.

The motion passed unanimously.

There being no further items of business to come before the Board, Chairman Pichini adjourned the meeting at 10:17 a.m.
